The Courses

Bachelor of Law (LL.B)

- Total Seats** : 120
- Course Fees** : **Rs. 40,000/- per year**
- Duration** : 3 Years (6 Semesters)
- Eligibility Criteria** : The applicant must have a Bachelor's degree of minimum 3 years duration or its equivalent. (10+2+3) from recognized university with minimum aggregate marks of 45% for General category, 42% for OBC and 40% for SC/ST as per Bar Council of India Rules of Legal Education, 2008. But in view of latest BCI Notification vide BCI:D:6539/2025 Dated 12.09.2025, if any candidate secured less than 45%(General category), 42%(OBC) and 40% (SC/ST) respectively in graduation as stated above, he should have secured same percentage or more on the aggregate in any Postgraduation. A candidate who has appeared in last year degree examination may also apply in anticipation of the results, provided he/she has to clear the last year examination at the time of admission.

30% of the seats are reserved for the Management as Management Quota (As per the decision of the Management)



Master of Law (LL.M)

- Total Seats** : 30
- Course Fees** : **Rs. 35,000/- per year**
- Duration** : 2 years (4 Semesters)
- Eligibility Criteria** : The applicant must have a LL.B degree of minimum 3 years duration from recognized university with minimum 50% aggregate marks. This criterion applies to all categories. A candidate who has appeared in last year examination may also apply in anticipation of the results, provided he/she has to clear the last year examination at the time of admission.
The admission procedure of LL.M, conducted by SAMS, Govt. of Odisha.

Note:

- There is no Fee Concession for Reservation or any other categories.
- Admission / Examination Fee and any other expense relating to lodging, boarding and other co-curricular activities will be paid separately by the students.
- All the above courses are recognized by Department of Higher Education, Government of Odisha and affiliated to Madhusudan Law University, Cuttack.
- **The students who deposit the entire course fees during time of admission in respective courses (LLB/LLM) shall be given 5% exemption of the total amount.**

Admission Procedure:

Admission to LL.B course will be held on the basis of career evaluation fulfilling the minimum eligibility criteria. Selection of the applicants shall be made on the basis of marks secured at Graduation level and Career assessment.

Admission to LL.M will be held through Higher Education Departments online Student Academic Management System (SAMS) registration.

Documents to be submitted with Application Form :

- Duly filled in Application Form signed by the candidate and by father/guardian at the places specified for the purpose



INTERNAL EXAMINATIONS FEES

A student has to pay Rs.1,000/- (Rs.500/- per Semester) in each year at the time of their admission.

Submission of Application:

- Duly filled in Application Form should reach the Principal, Bhubaneswar Law College, Bhubaneswar latest by the last date of receipt of forms either by hand or by Registered Post/ Speed Post.
- The College shall not be held responsible for any kind of postal delay. The candidates are, therefore, advised to send their applications sufficiently ahead of time so that they reach the College by 4.00 PM of the last date of submission of form.
- Last for submission of form is mentioned in the advertisement / college website subject to change by the authority, if needed.
- Incomplete Application, in any manner, or received after the last date **shall be rejected**.

Reservation : Reservation of seats will be as follows:

- SC-8% and ST-12% of the sanctioned strength of the College. These seats are not interchangeable among themselves.
- 1% of the seats for self/daughter/wife of Ex-servicemen.
- 3% of seats for Physical Handicapped students with more than 40% disability (Certificate from CDMO or equivalent officer is to be furnished).
- In any of the above reserved category, the balance lying, if any (after admitting the students of that category) shall be filled up by the general candidates as per merit list.
- Certificates not signed by competent authority shall not be considered for selection. Doubtful cases shall be referred to the appropriate authority for scrutiny.
- Claim for reservation shall not be considered unless it is supported by genuine documents.
- The selection/admission of a candidate shall be invalidated if suppression of facts, submission of false information or forgery of documents is detected during the process of admission or thereafter and such cases shall be reported to the appropriate authority who may draw criminal proceedings against the candidate concerned.
- Any false information found on verification of the original document at any stage will lead to cancellation of selection/admission and will be treated as a cognizable offence.

DECISION FOR ADMISSION

Admission to the College cannot be claimed as a matter of right. The decision for admission shall be made by the Principal, if satisfied, with the conduct of the applicant and information provided by him/her.

The principal reserves the right to cancel the admission of a student at any time, if he/she is convinced that the student conducts himself/ herself contrary to the discipline of the College.

CAUTION

Applicants are advised to go through the prospectus thoroughly before filling in / submitting the application forms and avoid misleading information from unauthorized persons to prevent possibility of rejection of application.

PROCEDURE FOR ADMISSION INTO LL.B / LL.M COURSE :

Information for admission would be sent to the selected applicants by Registered/ Speed Post/Email/WhatsApp and the selection list will be notified on the Notice Board of the College. Selected candidates are required to produce the following original documents at the time of admission.

- a. Intimation letter of College
- b. Original College/ Course Leaving Certificate of the last attended College/ University.
- c. Original Certificate/ Provisional Certificate and Mark Sheets of the qualifying exams.
- d. 10th Mark Sheet and Certificate
- e. Original Migration Certificate
- f. Five copies of passport size photographs.
- g. In case of duplicate CLC and affidavit from Executive Magistrate showing that, the original CLC is not used in any other educational Institution or any other purpose.
- h. Caste or Other Backward Class Certificate (In case of SC/ST/OBC/SECBC candidates).
- l. Handicapped Certificate (In case of PH candidates)

EXAMINATION

There will be two semester exams in a year. At the middle of each semester college will conduct Internal Exams. as per the instructions of the Madhusudan Law University and the University will conduct the End sem. Exam. Normally the Odd Semester exams takes place in the month of December and Even Semester exams takes place in the month of April/May of every year. The candidates have to attend classes in each semester as per university rules. For the purpose of appearing the University examination the candidates are required to deposit the examination fees as prescribed by the University from time to time. Ordinarily the form fillup of Odd Semesters takes place during the month of October and Even semesters in the month of March. It is the duty of the students to follow the College Notice Board as well as college website (w.w.w.blc.org.in) time to time for confirmation.

READMISSION

An eligible student is required to take readmission on deposit the course fees (if not submitted total fees during the time of admission), annually after receipt the communication through college.

AWARD OF DEGREE

On successful completion of the Courses and examinations (all the semesters) the candidates will be awarded degree by the M.S Law University.



Facilities

Building

The college building is located in one of the prime areas of Bhubaneswar offering excellent accessibility. The building covers the College Library and stock room for books, Moot Court Room, Seminar Hall, spacious conference room, Classrooms, Administrative office and research cell for faculties. All class rooms and halls are equipped with state of art facilities such as latest audio gadgets, projectors, smart-boards, lighting arrangement etc. needed for lectures, seminars, training programme and workshops.

Faculty

The college has the privilege of having mature, motivated and UGC NET/Ph.D qualified faculty on its roll and eminent personalities are also invited to deliver special lectures on special subject.

Library

A well equipped Library is a great platform to enable students to keep abreast of the latest changes and help them broaden their mind and vision. Bhubaneswar Law College boasts of large collection of books on various law subjects. The Library is well furnished with airconditioned and spacious and having large number of text books, reference books, journals, manuals, periodical and magazine concerning law and allied subjects.

Computer Lab

The college has a computer lab with internet facilities to enable students to enrich their knowledge with modern technology and access to online databases for legal research.

Moot Court and practical Training

The college has Moot Court facilities and it provides practical training through moot courts in

the college premises. The Moot Courts in the College is well equipped. The students are taken on an educational visit to the Courts at Bhubaneswar to the Session, District and High Court Cuttack and different civil offices as per the syllabus. This will enable the students to gain first-hand practical knowledge of the procedures adopted in the courts and prepares them to conduct themselves in dignified manner and to inculcate a spirit of Competitiveness among the students.

Hostel

The College offers separate hostels for boys and girls within the campus with well-furnished individual/shared rooms. The hostels provide mess facility with healthy and Hygienic food.

Internships

Since internships help the students to gain knowledge of the day to day working of the various bodies. The Bhubaneswar Law College encourages and sends the students for internships to various law institutions, different Courts, Law Firms, Senior Advocates, Corporate Bodies, PSUs, National and State Human Rights Commissions, National, State and District Consumer Forums, renowned NGOs etc.

The organization or Advocate under whom the internee is placed is required to follow suitable dress code.

Scholarships

The students can avail various scholarship schemes offered by the State of Odisha through its State Scholarship Portal including merit-based, means-based, pre-matric, post-matric and higher education scholarships with schemes like e-Medhabruti, Junior Merit and Post-Matric Scholarships for SC/ST/OBC/EBC students. They need to take note of date of application and



also last date of submission of forms as per their requirement.

College will not be responsible if any student fails to submit the application on time or failed to provide valid documents as instructed by the scheme / scholarships.

Seminars

On regular seminars are held on important legal subjects.

Guest/Visiting Lectures

For the benefit of the Students, College routinely organizes various Guest Lectures by Eminent Jurists, Senior Advocates of High Court & Supreme Court from time to time on topics of national and international relevance. This is necessary to keep the students updated about the legal problems and latest trends in the field of law and other related fields.

Attendance

- No candidate shall be allowed to take the end semester examination in a subject if she/he has not attend at least 75% of classes in all the subjects taken together for each semester, including the moot court exercise, tutorials and practical training
- A candidate may submit an application before the principal citing a reasonable ground for failure to attend 75% of the Classes. [The Vice - Chancellor (Madhusudan Law University) shall grant not more than 9 per cent of class room attendance to a candidate in such case (as mentioned under Regulation) i.e every candidate must attend at least minimum 66 percent of the class in aggregate. In the case of affiliated colleges, the case shall be forwarded to the Vice-Chancellor for condoning of the shortage of attendance]

A candidate who represents the Institution in any State/ National/International level Academic activities i.e seminar, moot court etc. and sports activities, their absence in the class shall be considered as present for the period attended/ participated.

Identity Cards

Students will be issued college identity card after the admission is granted. Every student should carry the Identity Card and produce it whenever required by a professor or member of the college staff. Identity Card shall be deposited when the student leaves the college.

Examination

All matters relating to LL.B & LL.M examinations shall be guided by the Examination Regulations of the Madhusudan Law University, Cuttack which may be procured by a student from the College Office at a nominal cost.

Rules & Regulations Dress Code

In order to maintain uniformity in the outfit of the students in the college campus a uniform dress code is prescribed for students. All students are required to wear prescribed uniform on all working days. Students not adhering to prescribed dress code, shall not be allowed to enter into the campus. Dress will be borne by students.

Students shall wear formal dress as follows-

1. For male students – white shirt, black trousers, black tie, black coat, black shoes.
2. For female students-white salwar /white shirt, blacktrouser,black coat and blackshoes.

- Students are required to dress decently. Dress code prescribed by college is mandatory.
- Use of cell phones is strictly prohibited. Students found using cell phones in class are liable to be fined.

The Following shall be deemed as acts of indiscipline:

- Resorting to ragging (Zero Tolerance Policy):
Ragging in any form is strictly prohibited and shall be treated as a serious offence. Any student found involved in ragging shall be liable to immediate expulsion from the college and shall also be subjected to criminal proceedings, including imprisonment and/or fine, as provided under the UGC Regulations on curbing the Menace of Ragging in Higher Educational Institution and other applicable laws in force.
- Smoking, consumption of alcoholic drinks, intoxicants and narcotic drugs.
- An act which causes destruction or defacing of the property of the college or organizing raids and breaking into the premises of college.
- An act which interferes with the personal liberty of another person or subject another to indignity, or involves physical violence or use of abusive language.
- An act in breach of an undertaking given under the rules of discipline.



- An act which causes interference of outside person or bodies or agencies in the functioning of the college.
- Dissemination & assertion of any false statement or tempering of certificates and records, whether with a view to seeking admission in a college or securing any benefit whatsoever.
- Collection of funds for any program, picnic, excursion, project or activity without prior written permission of the appropriate authority.
- Use of title of the college or title which includes the name of college for sending any letter or communication to the press or for distributing any documents or literature or publication other than academic work, without prior written permission of the appropriate authority.
- Use of the name or address of the college or its officers or other authorities for making any representation on behalf of any student or a group of student to any public authority in India or elsewhere or to any person (including the press) other than a person responsible for the management of the affairs of the college.
- An act which disrupts the smooth running of the college or environment conducive to the pursuit of knowledge or harmonious relationship between different groups of the students.
- An act which tends to lower the reputation, public esteem or image of the College or its Officers.
- An act of unruly and disorderly behavior at any competitions, sports, cultural activities or other social or educational programs organized by the college.
- An act involving moral turpitude.
- Breach of ordinances and rules relating to attendance at lecture tutorials, tests terminal or preliminary examinations and progress to the satisfaction of the principal.
- Being found in possession of any goods or materials deemed objectionable by the principal of the college. (In such cases, the principal may take or direct the taking of such goods or materials pending enquiry, if deemed necessary)
- Any act of insubordination or rude behavior or use of inappropriate language towards the principal or any professor of the college or non-teaching staff.
- Generally, any other act of indiscipline which, in the opinion of the principal of college is unbecoming of a student.
- Any student of the college who has committed one or more of the acts of indiscipline mentioned above shall be subject to the disciplinary jurisdiction of the principal, who may refer the matter to any professor or any committee of enquiry appointed for the purpose.
- Every student who has been alleged to have committed an act or acts of indiscipline shall be given an opportunity to be heard before any disciplinary action is taken against him/her.

MADHUSUDAN LAW UNIVERSITY
REGULATIONS FOR THREE YEAR LL.B. DEGREE COURSE
UNDER CHOICE BASED CREDIT SYSTEM

This regulations shall be for the Three Year LL.B. Course Choice Based Credit System is being introduced by the Madhusudan Law University and its affiliated Law Colleges from the academic session 2021-22 onwards. This course has been designed in accordance to the standards and regulations prescribed by the UGC and Bar Council of India Rules of Legal Education, 2008 from time to time.

1. Name of the Course

The Course shall be called as Three Year LL.B. course. This regulation has been come into force from the academic session 2021-22.

2. Duration

2.1 : The duration of three year LL.B. course shall be of six semesters (three academic years).

2.2 : The course leading to three years LL.B. course shall be conducted in semester system is not less than 18 weeks and not less than 30 lecture hours per week including tutorials, moot court exercises, seminars etc. provided there shall be at least 24 lecture hours per week.

2.3 : The 30 lecture hours shall be divided into five lecture hours and one tutorial for each paper per week.

3. Admission

3.1 : Admission to the three year LL.B. course shall be made through the entrance test conducted by the University or any other procedure as notified by the University from time to time.

3.2 : As per Bar Council of India Rules of Legal Education, 2008, no candidate shall be eligible for admission in three years law degree course unless s/he possesses at least 45% marks 40% marks in case of SC/ST candidates) in +3 or any other equivalent examinations.

3.3 : Reservation and relaxation in minimum eligibility for admission for SC/ST/PwD (Person with Disability)/ Ex-Serviceman/ Serving Defence Personnel/ Children of Martyrs as specified by Government of India, Government of Odisha, UGC and as notified by the University shall be followed.

<p>Ex-Serviceman (ESM), Serving Defence Personnel [SDP], Children of Martyrs. (CoM)</p>	<p>1% of the sanctioned seats shall be reserved for Self/ Children / Wife/ Husband of Ex-Serviceman, Serving Defence Personnel and Children of Martyrs.</p>

3.5: Foreign nationals either residing in India or abroad or Indian nationals abroad shall be admitted to the programme according to the policy guidelines laid down by the Government of India/ University from time to time as per the number of seats available for the category.

4. Medium of Instructions

The medium of instruction in all the courses shall be in English only.



5. Attendance

- 5.1 : No candidate shall be allowed to take the end semester examination in a subject if s/he has not attended at least 75% classes in all the subjects taken together for each semester, including the moot court exercises, tutorials and practical training.
- 5.2 : A candidate shall prefer an application before the Vice-Chancellor citing a reasonable ground for failure to attend 75% of the classes.
- 5.3 : The Vice-Chancellor shall grant not more than 9 percent of classroom attendance to a candidate in such case (as mentioned under Regulation 5.2) i.e. every candidate must attend at least minimum 66 percent of the classes in aggregate. In the case of affiliated colleges, the case shall be forwarded to the Vice-Chancellor for condoning of the shortage of attendance.
- 5.4 : A candidate who represents the Institution in any State/National/International level Academic activities, i.e. seminar, moot court etc. and sports activities, their absence in the class shall be considered as present for the period attended/ participated.

6. Course Structure

- 6.1 : The Three years LL.B. Degree Course shall comprise of 30 papers with 5 papers in each semester carrying 100 marks.
- 6.2 : Each paper consists of four credits. The total credit for the Course shall of 30 multiplied by 4 equal to 120 credits.
- 3.3 : The distribution of papers is given below.

7. Examination and Evaluation :

- 7.1 : A candidate for three year LL.B. degree course shall be required to appear in the examination for six semesters.
- 7.2 : The Controller of Examinations shall notify the end-semester examination schedule on completion of all the courses.
- 7.3 : Every theory paper shall carry 100 marks out of which 70 marks are for the end-semester examination and 30 marks for internal assessment.



- 7.4 : The end-semester question paper shall have five questions. Question 1 is compulsory and shall have four short questions from all the four Units and each question carries **3.5 marks**. The paper setter is required to set eight questions with two questions from each Unit i.e. Unit-I to Unit-IV. The candidate shall have to attempt four questions, selecting one question from each Unit. Each question carries 14 Marks.
- 7.5 : The distribution of the marks for the Internal Assessment is given below :

Internal Assessment – 30 Marks

- Mid-Semester Examination : 15 marks
- Written Assignment/Moot Court Exercise : 10 marks (5 marks each for written assignment and oral presentation respectively)
- Attendance – 5 Marks

The mid-semester examination shall consist of two questions from first two Units and the candidate is required to answer one question carrying 15 marks.

- 7.6 : The distribution of marks for the attendance is given below :

- 7.7 : **Medium and Duration of Examination:**

- The medium of examination shall be English only.
- The duration of mid-semester examination shall be of 45 minutes.
- The duration of end-semester examinations shall be of 3(three) hours.

- 7.8 : There shall be no theory examination and internal assessment for Moot Court. This paper shall be evaluated as practical paper consisting of assignments and Viva by the Committee constituted as referred under Regulation 8.

- 7.9 : In each semester there shall be moot court exercise/assignments for each paper. The distribution of moot court exercise and assignments in each semester for each subject is given below.



7.10 : For the practical courses, i.e. Arbitration, Conciliation and Alternative Dispute Resolution Systems, Professional Ethics, Drafting, Pleading and Conveyancing, the distribution of marks for the examination shall be as follows.

End semester – 48 marks

Mid-semester – 7 marks

Attendance – 5 marks

Practical – 40 marks (20 marks for written assignment and 20 marks for Viva-voce).

Note :- Both the assignment and Viva Voce shall be evaluated by the Committee constituted as referred under Regulation 8.

7.11 : Moot Court Exercise and Internship

This Paper shall have three components of 30 marks each and a viva for 10 marks.

- (a) Moot Court (30 Marks). Every candidate shall be required to do at least three moot court exercises in a semester with 10 marks for each. The moot court work shall be on assigned problem and it shall be evaluated for 5 marks for written submissions and 5 marks for oral advocacy.
- (b) Observance of Trial in two cases one Civil and one Criminal (30 marks) Candidates shall be required to attend two trials during sixth semester of the course. They shall maintain a proper record and enter the various steps observed during their attendance on different days in the court in a practical file. This scheme shall carry 30 marks.
- (c) Interviewing techniques and Pre-trial preparations and Internship diary (30 marks): Each candidate shall observe two interviewing sessions of clients at the Lawyer's Office/ Chamber and record the proceedings in a diary, which shall carry 15 marks. Each candidate shall further observe the preparation of documents and court papers by the Advocate and the procedure for the filing of the suit/ petition/ relevant forms. This shall be recorded in the diary, which shall carry 15 marks.
- (d) The proof to the effect that the candidate has attended the chamber/ office of the advocate/ counsel shall submit the form issued by the respective advocate/counsel.
- (e) The fourth component of this paper shall be viva-voce examination on all the above three aspects. This shall carry 10 marks.
- (f) This paper shall be evaluated by a Committee constituted as referred under Regulation 8



- 7.12 : The Controller of Examinations shall publish the result taking into account both internal assessment and end semester examination marks secured by the candidate.
- 7.13 : The internal assessment shall be conducted and evaluated internally by the respective institutions.
- 7.14 : The date for internal assessment shall be fixed by the Head/ Principal of the Institution.
- 7.15 : Where a candidate fails to take examinations in any one of more subjects or has failed to secure the minimum pass marks in one or more papers or in aggregate, her/his internal assessment marks shall be carried forward to the subsequent examinations.
- 7.16 : Every candidate must secure at least 50% marks in each paper in internal assessment. In case any candidate fails to obtain 50% marks or fails to appear in the internal examinations/he shall appear in the next respective semester (i.e. First, Third, Fifth semester and Second, Fourth, Sixth semester).

8. Committee for Viva-Voce.

- 8.1 : The Committee for Viva-Voce shall evaluate four practical papers namely, ADR, DPC, Professional Ethics and Moot Court.
- 8.2 : The Vice-Chancellor shall constitute a Board of Examiners for conducting Viva-Voce. The Board of Examiners for Viva-Voce shall consist of -
- (a) External member - Nominee of Vice-Chancellor: Chairperson
 - (b) Internal member - HOD/ Principal
 - (c) Internal member - Concerned Subject Teacher
- 8.3 : The TA/DA of the external member of the above mentioned Committee shall be borne by the respective institution.

9. Credit System

- 9.1 : The Course has five papers in each semester and each paper is having 4 credits, then the total credit for the paper of the semester shall be calculated as 4 Credits per paper. { For example – Credit per Paper x Number of Papers = 20 credits per semester)
- 9.2 : The Grade value shall mean the value assigned to the marks obtained by a candidate in a paper. Grade value is based on ten point scale.

9.3 : The table given below shows the marks range, grade value and corresponding letter grade.

9.4 : The Grade Point shall be calculated by multiplying the grade value obtained by the candidate and the credits of that paper.

For example - if the candidate secures the Grade value 07 and the credit of the paper is 04 then Grade point of the candidate in that paper shall be $7 \times 4 = 28$

9.5 : The Semester Grade Point Average (SGPA) of the candidate shall be calculated as the sum total of the Grade Point secured by the candidate in all the papers of semester divided by total credits of all the papers in that semester.

For example – if there are 5 papers in a semester and each paper is having 4 credits, total credit of the semester shall be calculated as $5 \times 4 = 20$

Therefore, $SGPA = GP 1 + GP 2 + GP 3 + GP 4 + GP 5$ (Grade point in all the five papers in a semester) divided by the total credits.

9.6 : The Cumulative Grade Point Average (CGPA) of the candidate shall be calculated as the sum total of the grade points secured in till date divided by total credit of the course till date.

For example - $CGPA = Total\ Grade\ points\ in\ a\ course\ divided\ by\ Total\ credits\ of\ the\ course.$

10. Promotion Rules

10.1 : A candidate who appears in the examination and fails to obtain pass marks in any course in the first semester, shall be permitted to proceed to the second semester but shall not be permitted to proceed from the second to the third semester without appearing in the examination and having qualified 50% of the total number of courses prescribed for first and second semester taken together. However, the candidate is eligible for provisional admission to third semester subject to the outcome of the result.



10.2 : A candidate who appears in the examination and fails to obtain pass marks in any course in the third semester, shall be permitted to proceed to the fourth semester but shall not be permitted to proceed from the fourth to the fifth semester without appearing in the examination and having qualified 50% of the total number of courses prescribed for first to fourth semesters taken together. However, the candidate is eligible for provisional admission to fifth semester subject to the outcome of the result.

11. Award for Degree

A candidate who successfully completes all the six semesters shall be eligible for the award of LL.B Degree from the University.

12. Maximum Years for completion of LL.B. Course.

The duration of three year LL.B. course shall be of six semesters (three academic years). The maximum duration for completing the course shall be of five consecutive academic years. If a candidate is unable to clear all the semesters of the program within the maximum duration of five years, she/he shall automatically exit from the program.


